Counties Plan Century Farm Recognition Events

Across Tennessee, fair boards and other organizations and agencies are recognizing local Century Farm families with special events each year. These events receptions, dinners, luncheons, exhibits, and other gatherings—are opportunities to focus on farms that are among the most historic places in each county. In addition to expressing appreciation to farm families, these events also educate the public about working farms and agricultural businesses and how they constantly contribute to our basic economy; maintain rural traditions and skills; and conserve open spaces, water sources, trees, and wildlife across the state.

If your county does not hold a recognition event for Century Farms, consider planning one for later this year or for 2010. To find out how many Century Farms are in your county and to learn about their history, visit the Tennessee Century Farm Web site at http://www.tncenturyfarms.org.

This year, fourteen fair boards applied for and received grants from the Tennessee Department of Agriculture to help offset some of the expenses associated with their Century Farms recognition events. These fairs are: Cumberland, Dickson, Dyer, Foothills, Franklin, Greene, Hardin, Hickman, Houston, Lauderdale, Meigs, Putnam, Trousdale, and Williamson.

In addition to fair boards, other organizations that have sponsored local recognition events include Soil Conservation Districts, historical societies, and county extension offices. Barns of Tennessee Now Available


In the summer 2007 issue of this newsletter, we invited Century Farmers to submit photos for a forthcoming book on Tennessee's barns. From across the state, readers of the Tennessee *Magazine*, the popular monthly publication of the Tennessee **Electric Cooperative Association** (TECA) were also invited to send photos of barns. Over the next few months, over 3,500 photographs were submitted, many from Century Farm families. Barns of Tennessee, coauthored by Caneta S. Hankins and Michael T. Gavin, designed by the staff of the *Tennessee Magazine* including editor and photographer Robin Conover, and published by

Donning Company Publishers, was released earlier this year. The book, representing every county and containing over 350 photographs, describes types and

uses of barns and includes stories provided by the owners. *Barns of Tennessee* is available for \$45 plus \$5 shipping and handling through the TECA office at 710 Spence Lane, Nashville, TN 37224, and on the TECA Web site, www.tnelectric.org. A field session on October 14 will visit the Gentry Century Farm in Williamson County to learn about the history of the farm, established in 1848, and to observe and participate in educational and agritourism activities that are part of the farm's diverse operations today. Century Farms director Caneta Hankins will lead the field session along with Lynne Williams, Century Farms liaison with the Tennessee Department of Agriculture. Hankins will also present an educational session on the Tennessee Century Farms program October 16 at the conference. 
Protecting Your Land: Enhanced Tax Incentives

In 2008, Congress enacted significant changes to the federal income tax incentives for conservation agreement donations:

- The deduction a landowner can take for donating a conservation agreement was raised from 30 percent of his/her income in any year to 50 percent.
- Qualified farmers and farm corporations are allowed to deduct up to 100 percent of adjusted gross income.
- The number of years a donor can take these deductions was increased from 6 to 16 years beginning the year the donation is made.

HOWEVER, the law stipulates that the changes will expire December 31, 2009, and the old tax law will again be in effect.

If you or someone you know is considering taking permanent action to ensure that your land stays open and green for your children and grandchildren, talk to your tax advisor and/or contact the Land Trust for Tennessee. The Trust's staff predicts that the expiring tax incentives will make 2009 another record year for protecting farm land, and they would like to start the process with potential landowners earlier rather than later in the year. Doing so will ensure plenty of time to work together through the specific decisions you must make about your land's future uses. If you or anyone you know is considering a conservation agreement regarding land, now is the time to call the Land Trust for Tennessee and set up an initial site visit.
